1. Integral Scaffolding trading terms are strictly 15 Business Days from the date of invoice, as per the *Building and Construction Industry Security of Payment Act 1999 (NSW) (NSW Act)*
2. Interest charges are applicable on all outstanding amounts from due date, in line with your contractual agreement, or at the prescribed rate at which interest is payable under *section 101 of the Civil Procedure Act 2005 (NSW)*.
3. Credit facilities may be withdrawn with a notice period of one (1) week, if payment of invoices exceeds our 15 Day payment terms.
4. You are subject to any penalties and/or legal costs in the collection of overdue accounts.
5. Personal Property Securities Act 2009.

 - A minimum three (3) month hire will be charged for ReadyFence hired.
 - Loss and damages of equipment will be charged to the Applicant at cost.
